TERMS OF REFERENCE/SCOPE OF WORK

APPOINTMENT OF A SERVICE PROVIDER TO CONDUCT CROWNED EAGLE MONITORING ON SELECTED SAFCOL PLANTATIONS FOR THE 2026/27 PERIOD.

Purpose:

To establish whether the African Crowned Eagles populations on selected SAFCOL / Komatiland plantations in Mpumalanga Province are being impacted by plantation forestry activities and to make management recommendations to minimize potential negative impacts while maximizing positive impacts.

Specifications

1. Visit all known Crowned Eagle nest sites in the beginning of the breeding season (**September 2026**) to determine if the nesting site is active for the current season.
2. The monitoring / observing and documenting of all active Crowned Eagle nest sites where breeding has been identified to determine the 2026/2027 breeding success at these sites.
3. The identification and documentation of all new nest sites.
4. While monitoring the breeding success of the African Crowned Eagles pairs, sightings of other RTE bird species are also to be documented. (Peregrine Falcon, Lanner Falcon, Black Stork, etc).
5. To conduct reconnaissance to other SAFCOL / Komatiland Forests where there is suitable habitat for potential crowned eagle nesting sites.
6. The following plantations are included within this programme:

7. Every known **active** African Crowned Eagle nest on Komatiland properties in the Mpumalanga lowveld / escarpment should be monitored a minimum of four times during the breeding season during the periods as indicated below:
 - Monitoring of existing nests (**September 2026**)
 - Establish whether the pair has laid eggs, (**October 2026 – November 2026**)
 - If the chick survives to fledging and (**December 2026 – January 2027**)
 - Successfully fledges (**February 2027 – March 2027**)

This sequence on monitoring will indicate the breeding success of the species.

8. A monitoring schedule shall be provided, taking into consideration the service providers other commitments and weather conditions.
9. The project is to commence, **on receipt of a Purchase Order, no later than September 2026**. By 15 March 2027, the project shall be completed. Completed includes the submission of the invoice and statement. Payment will be 30 days (End April 2027)
10. The service provider must provide all materials and equipment to perform the task. (Note: Extensive use of gravel plantation roads is required. The condition of these roads may vary from good to poor)
11. The service provider should be able to respond at short notice to observe birds when displaying. Plantation staff are encouraged to report such sightings to the appointed service provider.
12. Visits to the sites must be pre-arranged with the respective SHEQ (Environmental) / Plantation Manager.
13. Provide insight to animal activity below active nests by recording such activity with trail cameras.
14. Where there is a potential impact due to forestry activities in the immediate area where breeding is taking place (eg Harvesting / weeding operations), engagement timeously with the Environmental Practitioner and the Plantation Manager must be done to minimise the disturbance. A summary of these engagements, if they were required, to be included in the final report, due end March 2027.
 1. Reports must be finalised and provided to Komatiland Forests in a user friendly format (Word / PDF).:
 - Description of each nest, height above ground, nest tree type, co-ordinates, etc (after each site visit).
 - The report must highlight which nest sites provided successful breeding.
 - Identify prey remains below nests, when possible.
 - Comprehensive report by **15 March 2027**.
 - Inclusion of supporting photographs, including those obtained from trail cameras.
 - Provide information regarding the larger picture of the health of the crowned eagle population in the wider landscape.
 - Provide recommendations / guidance as regards reducing the impact off forestry activities in the immediate area that can affect the success of breeding.

- The information must be compatible with the requirements of the greater Birdlife Lowveld research project.
- Along with the report, the service provider must provide an invoice and statement for the completed work. The invoice and statement must provide the information as provided on the official order and include the service providers contact details and the SAFCOL Vat number. Payment will be processed on completion of the full project.(30 days). No partial payments can be made during the project.

15. The service provider must include in his quotation, a feedback session to provide management and interested staff the outcome of the monitoring. This presentation will be in the form of a virtual session by using Microsoft Teams or a similar platform. This approach allows a lot more interested staff members to gain insight of the project. The presentation is to be provided to KLF.

16. Requirements from the potential service provider:

- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed
